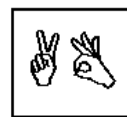
### 1. INTRODUCTION OF GUESTS/SPEAKER (if any) - None

- a. **Nachi** – Attended an HRC meeting last year. At the time decided not to speak on his issue because he had an open case in the courts. Now that his case is over, he wanted to update the HRC on the results and to report that he felt the Fairfax Police and County Sherriff’s deputies profiled him during a police stop on Jan 7<sup>th</sup> 2012 in Fairfax and wanted to alert the HRC to this incident.
- b. **Thiele** – Sheriff complaint/issue. Thiele reported that he was tazed 3 times in Novato near San Marin exit. He felt that excessive force used. He was tazed above the heart – which is potentially lethal. He said he has not functioned the same since this incident and was hoping the HRC would look into his case.
- c. **Pegelow** – Cultural Services Dept. complaint. Pegelow reported that the CSD requires that minority events have excessive police protection, while non-minority events are not held to the same requirements. There is an upcoming event scheduled that he feels is an example of the unequal treatment. AA reported that he met with CSD Director, Jim Farley who denied the allegations and is willing to meet with the HRC and any complainants about the issue. Pegelow also mentioned that he felt there was profiling at the County Fair in which minority men were targeted. Pegelow suggested that the Commission gather evidence of these incidents to present to the BOS and show the pattern. The ACLU has written letters to the County. CM to set up appt with Farley and Pegelow to discuss.

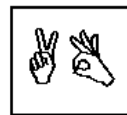
