V. Speaker: Roger Crawford, Equal Employment Opportunity Director, Marin County

Roger: Speaking on representation of women in Marin County (in the context of moving away from the consent decree)

- 2 year action plan includes hiring, retention & promotions
 - o People of color & women of color
 - Mentoring program & other ways to develop & create inclusive environment
 - 5 steps for every classification
 - o When you get to step 5, everyone's classification is the same
 - Disparities not immediately apparent

- Won't see disparities in average worker who has worked a number of years
- Won't see disparities in promotion rates
- Disparities may happen when initial offer is made during initial hiring process
- Will see disparities in pension rates
 - Makes a difference when people are hired in at different steps
- 5 year Business Plan
 - Goal is to interview women & person(s) of color for every upper level position that becomes available
 - For reference:
 - Upper-level Management
 - Department Heads
 - Assistant Department Heads
 - Middle Management
 - Supervisors of supervisors
 - Primarily in HHS
 - Entry Level
 - Supervising line staff (i.e. eligibility workers, library desk staff supervisor, etc.)

Request for additional information:

- Education level of women typically hired within the county (Not an EEO data point, NeoGov data point) and how does this tie in with pay
- Preponderance of certain jobs? (i.e. more men in maintenance jobs?
- Request numbers in addition to percentages
- Exit surveys
- Request for the slide deck used in this presentation

 - One position is finalized

Leslie:

- Good News- We have received the 25K grant. Thanks to Crystal for uncovering where it was
 - 1) Next step We can move forward with projects
 - Sherene & I will meet with grantor soon
 - Will ask to extend reporting requirements
 - o Received money now and others rec'd in April
 - o Requesting extension until October of next year

- Spending & reporting protocol of sub committees
 - What will reporting protocol look like
 - Pictures, reports & details of how we are building capacity
 - Keep your records to provide when we ask for them for reporting purposes
- Official file in drop box includes:
 - Award grant
 - Progress report (everything in report & discussed in meeting), etc.
- 2) Next thing Will send in email through proper channels
 - If one of us has expenses, how to handle these
 - Solange answered a good portion of questions
 - Everyone should <u>sign up with county to become a vendor</u> and fill out proper form(s) in order to be paid
 - If we know we plan to use a particular vendor have them sign up in advance to get the ball rolling now
- 3) Communication Need to communicate about what our plans are going forward
 - Encourage everyone to go to Dropbox & read application
 - Goal is capacity building.
 - We should all know about this
 - Will take all of us moving forward & reporting back

VIII. Budget Review and Fundraising

Presented by Commissioner Sally Stocks and Crystal Martinez

- Our account is not evergreen and needs to be spent down by the end of each fiscal year
 - o Grant money located through DOF and will be in the account and accessible any day
- Vendor system & payables within the County
 - Must be set up as vendors within the county system to be repaid
- Solange Grey in HR is "go to" person for questions
 - o Talking to Solange about admin & Marin Women's Commission account
- Budget is \$13,500 every year
 - Primary use is supporting MTGC
 - o MWC pay 10K towards conference annually and ask BOS to match
 - o Pandemic canceled MTGC & resulted in leftover funds
- Roughly 15k (for financial conference and MTGC)
 - o Funds put into the account with the understanding it would be spent down
 - o Has been in existence for over 6 years
 - Puts us in a great position to make MTGC a recurring event, can pre-pay next year's MTGC
 - Don't yet have confirmation that it zeroes out every year
- Paypal Account need to confirm with Chris Shaw how to access this

- (suggested titling) Women Run for Office, Boards & Commissions
- Event will fit well under listening tour grant
- Magali presented great idea
 - Women who have successfully run for office to encourage others on how to run & how to serve on a commission
- Partnership with Denise (Director for Institute of Leadership Studies and in charge of Business school) at Dominican has moved quickly
- Got partners in place before we had a plan
- Will be in Creekside Room in Dominican
 - o Dates will be April 4,5 or 6 (5th is Passover, but had to give Dominican 3 dates)
 - Light refreshments from 5.30 to 7pm
 - Denise & a few others will moderate
 - ILS will partner with us & provide \$700
 - o Required to use Dominican's catering service
 - \$15 per ticket
 - Managed by Magali through Eventbrite
 - Proceeds will go to MTGC
 - Tickets are Holding space and will track the number of guests
